The following Annual Admission Notice has been prepared by the board of Dunshaughlin CNS in respect of the admission of students to the school for the school year 2026/2027. This notice was published on 1/10/25

Note: The figures set out below in relation to Junior Infants are subject to increase dependent on the overall student teacher ratio in the school at the time of the administration of the school's admission process for applications to the Junior Infant class.	
Total number of places available in Junior Infant Group:	26
Total number of places available in classes other than the Junior Infant Group:	To a maximum of 30 places per class where the pupil teacher ratio of 23:1 is not achieved across all the classes in the school. This number may also be exceeded if required to meet staffing allocation pupil numbers.
